

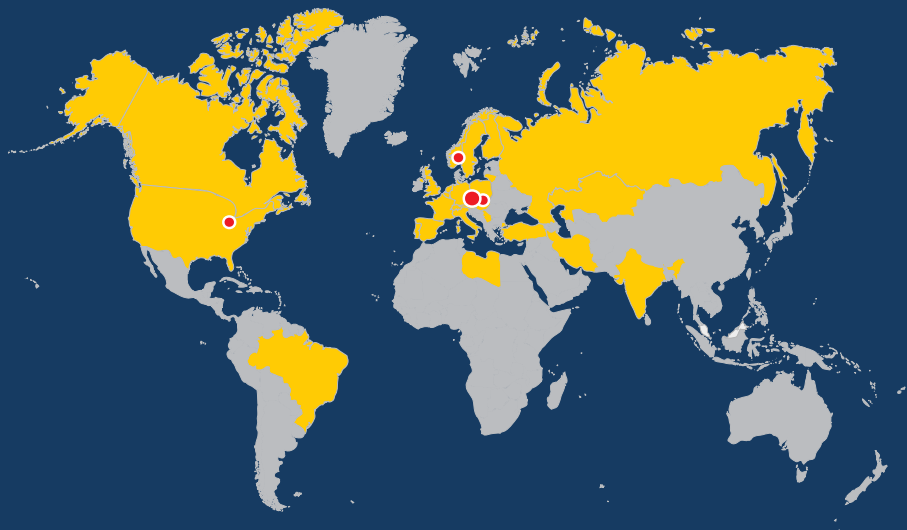
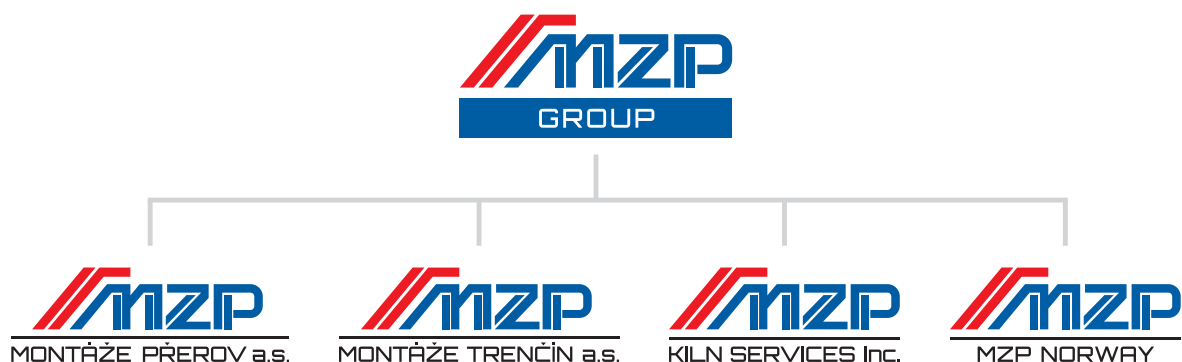

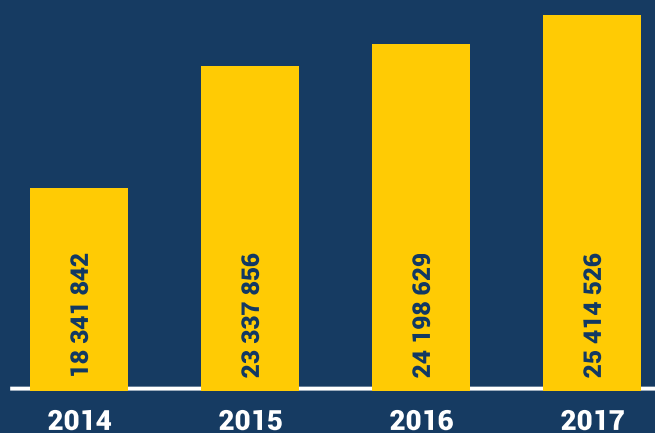
Over the years 2014 to 2017 the outputs of our company grew by 7 mil. EUR in absolute numbers, which means an increment by 38 % in relative numbers.

The output growth was not disturbed by any external economic factors (the economic crisis fading, economic fluctuations in some markets etc.).

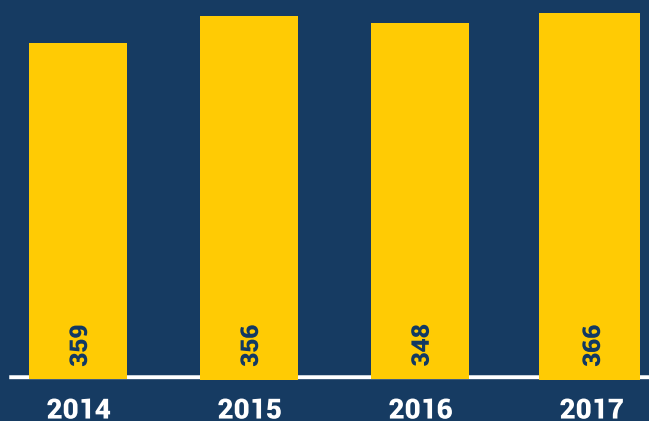
MZP Group maintains a stable number of regular employees while continuously increasing the outputs.

PROJECT DESCRIPTION

Installation and commissioning of 3 lines of technological equipment for processing of tree trunks into wood chips (spruce, pine, birch), installation and commissioning of 3 pcs of wood chip storage facilities and welding of 3 pcs of debarking drum shells.

MZP GROUP took part in building the first next-generation bioproduct mill in the world. With a value of EUR 1.2 billion, this plant has become the largest investment in the history of the Finnish forest industry. Our realization team from Montáže Přerov a.s. and Montáže Trenčín a.s., numbering 75 workers at peak, was a part of an international team numbering up to 2300 persons at peak. Besides accomplishing highly demanding assembly activities we had to cope with very harsh conditions of the Finnish winter.

The order was extraordinary by the volume of the installed technological equipment for a period of one year. We have met the customer's principles applied for building a plant:

- No accidents
- Elimination of the grey economy
- Responsibility for the living environment

PROJECT DESCRIPTION

From the second half of September 2016 to 20/3/2017 our company realized a complete reconstruction of a cement plant exchanger for our client Aliacem s.r.o. The project investor was LafargeHolcim company, the world's largest manufacturer of structural materials, a place of realization was a production plant Zementwerke Mannersdorf, Austria. MZP GROUP was a supplier of assembly works and, at the same time, a supplier of a part of technological equipment.

A total weight of the demounted technological elements and newly installed parts and steel structures exceeded 1000 tons. Heavy load handling was carried out using our own mobile mechanization - Grove 6400 mobile crane, LTM 1025 mobile crane and Genie manipulator.

The project was extraordinary in term of time demandingness and a scope of works. Just before beginning the shut-down, while the kiln line was still running, needed modifications were carried out and existing steel structures of the exchanger tower were strengthened prior to mounting the new technology, which required very strict safety measures. Further, when the line was shut down, a perfect coordination of demounting works with demolition of linings of the existing technology was demanded. The very assembly of the new technology performed concurrently with installation of new linings into the newly installed technology was highly demanding as to coordination as well.

All of this was topped by executing all the tasks within the required time schedule and, above all, not a single accident occurred.
